FRNSA Attorney reported positive feedback

- Modified offer to purchase documents sent to Eagle Flats legal counsel requesting more detailed financial information, building plans, specs, etc. requested information back by 2.7.20. Received information back by 2.6.20.
- Presented \$2.5 mill offer for building to FRNSA.
- Discussed timing June/July date of breaking ground w/o any delays.
- Need to finalize site drawings, agreement w/city on ongoing maintenance, environmental issues for soil management which could take several months for DNR approval
- 1 year after start of construction before FRNSA can build out the inside of the building
- Contractual provisions could be completed in next couple of weeks.
- Discussion regarding building design, parking access, bus access
- Discussion about recouping OMNNI's cost investment in the project
- FRNSA Attorney will confirms FRNSA payout for work done by OMNNI, clean up the contract, work on project timeline, consider contingencies and joint venture agreement.
- Visitor Center to be funded through loan and subsided by fundraising.
