  - 1. Discussion Jason Kent presenting on October 18, 2019 they submitted a Proposal for Round Goby studies. FRNSA authorized Kleinschmidt to begin work on Tasks 1 and 2 of that scope of work on October 22, 2019. Kleinschmidt has submitted Change Order No. 1 for change in scope and budget related to additional fish collection work to support the laboratory studies of Round Goby swimming speeds and electrical field response thresholds. They are seeking the authorization to proceed with the two laboratory studies (Tasks 3 and 4), included in the October 18, 2019 proposal, in a phased approach.
  - 2. Task 1-Pilot Study for Round Goby spawning hatching and rearing in the laboratory. GLEC (Traverse City, Michigan), Initial Study to collect adult and larval Round Goby
  - 3. Task 2: Six-week Round Goby collection effort 8/13/2020 to 9/23/2020
  - 4. Task 3: Electrical field threshold study from 9/14/2020 to 9/25/2020
  - 5. Task 4: Laboratory swim speed study from 9/14/2020 to 9/18/2020
- 3. Recommendations:
  - 1. Add 6-week collection effort prior to experiments:
    - 1. Start in August
    - 2. Daily trap sets and check minnow traps and light traps
    - 3. Weekly beach seining
    - 4. One SCUBA collection event (focus on larvae)
    - 5. Increase scope and budget
    - B, Move up experiment to early September
      - 1. Target: Week of September 7 or 14
      - 2. Same Scope as original; no additional scope/budget indicated will not exceed \$15,000.

Discussion – Ron asked if the water quality in Traverse, MI is similar to that in the Fox River. Jason responded, we can make some adjustment to the water quality if needed.

The laboratory is different than that of the field. We can make adjustments.
