    - i. Distributed to Board of Directors members
    - ii. Routed to attorney, Andy Rosseissl, to review
- 2. Insurance letter to DOA showing FRNSA is not able to obtain insurance
  - a. Phil Ramlet and Ron Van De Hey visited DOA in December to request insurance coverage
    - i. DOA will investigate why FRNSA had started purchasing their own insurance
    - ii. Currently receiving \$125,000.00 per year from WI State Budget
      - 1. Must be requested through DOA
      - 2. Jeremy Cords requested funds in December 2022
        - a. Funds received
        - b. Amount has been static
          - i. Propose to use CPI going forward
          - ii. Lease expires in 2034
          - iii. Proposal to renew lease early
- 3. Request bid packages for Westwood for 2023 projects
  - a. Complete RFP report will be available to Board of Directors at March 28, 2023 meeting
  - b. Bid packages expected to be available from Westwood in March or April
- 4. Discuss virtual meeting requirements with attorney, Andy Rossmeissl, from Herrling Clark to clarify:
  - a. Can a different agenda be posted publicly than what is sent to board members
    - i. Agenda can differ from what is submitted to public; however, it must be made available upon request in compliance with an Open Records Request
      - 1. Phil Ramlet will confirm this information with DOA
      - 2. Some board members have an understanding that there can only be one agenda for members and public
      - 3. Since FRNSA is considered a "quasi" state agency, some state regulations and requirements may or may not apply. At times, FRNSA needs to decide which items may apply or not, it isn't always clear what category FRNSA falls into.
  - b. Require public to be "in person" and not virtual even if it's an option for board members to attend virtually
    - i. Yes, FRNSA can require public to appear in person versus virtually, even if board members have a virtual option.
      - 1. Board members are concerned that people can virtually attend without identifying themselves
        - a. May be able to require callers to sign in and request link to maintain a roll call
