2024 Lock Season Schedule

Northern Locks (De Pere and Little Kaukauna)

- May 18-September 2 - open 10a - 8p Mondays through Sundays
- Holiday Schedule - Memorial Day, Fourth of July, and Labor Day 10a - 8p
- After Labor Day - open 10a - 6p Saturdays and Sundays until October 6
- October 5 & 6 - Free Fall Colors Weekend 10a - 6p
- De Pere Lock (920-227-7024)
 - Extended Hours
 - Open until 8:30p for Knights on the Fox Concert Series Tuesday nights July 9, 16, 23, 30 and August 6
 - When the City of Green Bay hosts their Independence Day fireworks, the De Pere lock will stay open until 11pm to accommodate the boat traffic – that date is yet to be determined.
- Little Kaukauna Lock (920-227-7043)
- Phones active only during hours of operation
- Closed
 - Rapide Croche Lock - Closed since 1985 due to discovery of the Sea Lamprey.

Southern Locks (Kaukauna through Appleton)

- May 18-September 2 - open 11a - 6p Saturdays and Sundays
- Holiday Schedule - Memorial Day 11a - 6p, Fourth of July closed, Labor Day 11a - 6p
- Kaukauna Locks 1, 2, 3, 4 and 5 (Lock 1: 920-202-1855) and (Lock 5: 920-809-3299)
- Combined Locks (920-809-2189)
- Little Chute Lock (920-750-3309)
- Cedars Lock (920-750-3309)
- Appleton Locks 1, 2, 3, and 4 (Lock 1: 920-750-3306) and (Lock 4: 920-750-3307)
- Phones active only during hours of operation
- Closed
 - Menasha Lock - Closed since 2015 due to discovery of the Round Goby.

**Fees****Season Pass - \$100**

- A permanently affixed season pass is valid all season.
- All passes are non-transferable.

Recreational Day Pass - \$10

- A daily pass is valid for one day, at open locks on the Fox River for motorboats and non-motorized boats.

Commercial Vessels - \$80 Per Trip

Tour Boat - \$80 Per Trip

- "Tour Boat" means a motorboat transporting passengers to gain profit.
 - Trip 1 De Pere and Little Kaukauna (Little Rapids)
 - Trip 2 Combined Locks, Little Chute Lock and Cedars Lock
 - Trip 3 Appleton Locks 1, 2, 3, and 4

Scheduled Paddle Events - \$1.00 Each, Minimum 25 Participants Per Lockage.

- "Scheduled Paddle Events" are publicly advertised at least one month prior to the event in local newspapers and / or other media outlets.

Special Lockage - \$250 Any lockage taking place outside open hours requires 48-hour notice and pending staff availability.

- Motorized, Non-Motorized Boats, Commercial Vessels, and Tour Boats.
- Schedule a Special Lockage at Foxlocks.org or by phone at 920-288-7505
- Cancellation of Special Lockages within less than 24 hours' notice results in a \$40 cancellation fee.
