- V. Executive Director Phil Ramlet
 - A. Menasha Update Round Gobi
 - 1. Discuss
 - a. Ashley Dooley's synopsis of round goby reported in Lake Winnebago near the Bowen Street Fishing Pier in Oshkosh on June 2, 2025. After being confirmed as a round goby by DNR fisheries and aquatic invasive species staff, DNR staff conduct an angling and trapping 'blitz' to determine if additional gobies are present in the system. Shore angling, boat angling and minnow traps were implemented from June 2 through June 6. However, no round gobies were captured through these efforts and no additional angler reports have been received, indicating that there is not currently an established goby population in Winnebago System waters. DNR continues to consider the Menasha dam, Neenah dam and the closed Menasha lock essential barriers to preventing the spread of round goby to Lake Winnebago.
 - 2. Ashley Dooley requested that FRNSA have UWGB report any Round Gobi found during trapping/research to the DNR in real time
 - B. Menasha Update Portage(s)
 - 1. Phil Ramlet stated that FRNSA is waiting on the City of Menasha to select the portage location
 - C. Friends of the Fox (FOF) Parcel Donation
 - 1. Update
 - a. Attorney, Andrew Rossmeissl, is working with FOF to get through their bylaws and to get paperwork completed
 - b. Anticipated completion date is August or September 2025
 - D. Appleton Canal We Energies Settlement
 - 1. Update
 - a. Attorney Andrew Rossmeissl, has made modifications to the offer received by We Energies and has sent back to them for review
 - b. Phil Ramlet has contacted the Department of Administration (DOA) to help FRNSA with attorney fees
 - E. Ahlstrom
 - 1. Update
 - a. No rent has been received for the last twenty years
 - i. No current lease is in place
 - ii. Settlement of \$100K was not acceptable to DOA

- iii. Attorney, Andrew Rossmeissl, is working on "cross use access" so FRNSA can go on Ahlstrom property and vice-versa,
- iv. FRNSA inherited lease from the Army Corp of Engineers (ACOE) when transfer of documents took place in early 2000
- b. Ahlstrom currently not paying any rent
 - Phil Ramlet states that Ahlstrom has removed all items that were located on FRNSA property; however, Ahlstrom has a railroad spur that runs on FRNSA property
 - ii. Question as to why Ahlstrom is not currently paying rent, Phil Ramlet stated that our maintenance staff have a good relationship with Ahlstrom's maintenance staff and thinks that relationship is important to maintain
- c. Contamination on property due to chemical leaks by Ahlstrom
 - A Phase I Site Assessment has been completed, but not a Phase II Site Assessment
 - ii. Phil Ramlet states that Ahlstrom will be responsible for cleaning up contamination
 - a. Anticipates that contaminated soil will stay in place and be capped, not disturbed
 - b. Tom Mace points out that contamination would leak into the water
 - c. Ashley Dooley will see if a Responsible Party (RP) letter was ever submitted for this site
